## **Privacy Policy overview**

Our privacy policy is made under the REG.UE 2016/679/UE, (especially the article n°13), called GDPR. The following gives a simple overview of what happens to your personal information when you visit our website.

## **Data collection purposes**

Form data are used to satisfy your information request. Part of the data is collected to ensure the proper functioning of the website. Other data can be used to analyze how visitors use the site.

## **Web site visitors rights**

### **Data collection methods on our website**

Some data are collected when you provide it to us, for example when you fill our contact form. Other data are collected automatically by our IT systems when you visit the website. Our web pages use cookies: they do not harm your computer and do not contain any viruses. Cookies help make our website more user-friendly, efficient, and secure. Cookies are small text files that are stored on your computer and saved by your browser.
